## 4. Guidelines for Admission

- 1) Prospective students must first apply through the Calicut University Centralized Admission Process (CAP). Only those applicants registered through UGCAP will be admitted.
- 2) All students allotted to Zamorin's Guruvayurappan College, Kozhikode under UGCAP should first complete online verification and then report at the College on the scheduled date after remitting the mandatory fee to the University.

Note: Attested printouts of all relevant documents need to be carried by the applicants.

### 3) Community Quota:

- a. The applicants under Community Quota must have applied through UGCAP.
- b. While applying through UGCAP, the applicants must ensure that they have given Zamorin's Guruvayurappan College, Kozhikode as an option.

- c. Once the Community Quota list is issued by the University, the list of the Applicants allotted to Zamorin's Guruvayurappan College, Kozhikode will be published on the College website and the notice board.

**4) Management Quota:**

- a. The applicants under Management Quota must have applied through UGCAP.
- b. While applying through UGCAP, the applicants must ensure that they have given Zamorin's Guruvayurappan College, Kozhikode as an option.
- c. The applicants under Management Quota need to fill out an additional online application form. The form can be accessed at [www.zamorins.org](http://www.zamorins.org).

**5) Sports Quota:**

- a. The applicants under Sports Quota must have applied through UGCAP.
- b. While applying through UGCAP, the applicants must ensure that they have given Zamorin's Guruvayurappan College, Kozhikode as an option.
- c. The applicants under Sports Quota need to fill out an additional application form. This application form, along with all the relevant documents, need to be sent as an email to [zgckozhikode@gmail.com](mailto:zgckozhikode@gmail.com).

**6) Lakshadweep Quota:**

- a. One seat in each UG is additionally created and reserved over and above the sanctioned strength.
- b. These candidates need not obtain permission from the University for late registration up to the closing of admission to the respective programmes of study.
- c. If there is no claimant from among the Ethnic Native Scheduled Tribe Candidates from the Union Territory for the seat reserved for them for degree programmes, the seats thus falling vacant due to their absence, will be allotted to the children of the employees belonging to Kerala State who have undergone Plus Two education in the Union Territory of Lakshadweep. The admission shall be made only after obtaining prior permission from the University.

**7) Transgender Applicants:**

- a. Two additional seats in all programmes in affiliated colleges is reserved for students belonging to the Trans-gender category.
- b. The students wishing to take admission to this category shall register through CAP. The admission to this category will be conducted directly by the Directorate of Admissions (DoA).
- c. The candidates should produce the identity card and certificate issued by the Social Justice Department while reporting for admission.

- 8) While remitting fee through Akshaya centre, make sure that the contact details entered are that of the applicant or their parent/guardian.

9) All admission to the College is provisional and subject to verification and approval by the University of Calicut.
